

Take5studio Studio Rental Contract

Waiver of Liability

Take5Studio rents its facility, including limited equipment, to its customers with the understanding that in no event shall Take5Studio be held liable for direct, indirect, incidental, or consequential damage due to the use of this facility or equipment used by its customers. I hereby waive and hold harmless Take5Studio from any incidents or accidents which may occur to or by persons either renting or associated with the renting of Take5Studio on the dates noted above, or any additional dates added later.

Studio Rental Rates

Rates are B.D. 125 per half day or 4 hours and B.D. 200 per day or 8 hours. A non-refundable* booking fee of 50% of either rental options is required in **advance** to secure a date, which will be applied toward the balance due. A fee of B.D. 20 is required as a cleaning deposit, which will be refunded after a full inspection of the premises after renter vacates. Full payment is required on the day of the shoot prior to the usage of facility, with no exception.

Customers are encouraged to bring along their own props, décor accessories, with the obligation of removing/hauling them away immediately after the end of the rental time.

Cancellation Policy

48 hours notice prior to booking date	50% of rental
72 hours notice prior to booking date	25% of rental
1 week prior to booking date	No charge

Responsibilities

- 1-** Renter accepts the studio equipment and accessories, and agrees that it is in good condition at the inception of this rental agreement.
- 2-** Renter also agrees that if any equipment, furniture, fixtures, etc. are mishandled, broken, ruined or stolen while they are using the studio that they will replace the items or pay repair/replacement costs within 48 hours.
- 3-** Leaser retains all right, title, and interest in and to the Studio equipment & facilities and therefore maintains the right to terminate this lease at any time and recover Studio equipment if not promptly returned by the renter or if renter is violating any Studio rules and regulations. Renter shall be liable for any and all costs incurred by leaser in the recovery process of equipment.
- 4-** Renter will leave studio clean and neat just as they found it, furniture put back, all lights, sound system, and equipment off.

5- All modelling lights are to be turned off when not in use.

6- Items left in the Studio by the renter will be assumed abandoned after 7 days of date of rent and may be discarded by the Studio.
